DISRUPTIVE THINKING: HOW TO SPARK TRANSFORMATION IN YOUR BUSINESS · 9:00 to 10:30 A.M.

Successful companies operating in mature industries that embrace incremental change find themselves on a path that gets narrower and narrower. Eventually, they reach the end of the path, and by then, their customers have forsaken them for a new offering that nobody saw coming. In cases where companies do take disruptive risks, it's often because they're backed into a corner and there's no other choice. But companies that try to differentiate themselves by focusing on incremental innovation instead of game-changing, disruptive innovation will differentiate themselves right out of business. They cannot afford to wait until they get backed into a corner. Companies need to be consistently making bold moves, even at the very peak of their success. It is an essential skill for anyone in business, from a small startup to a global corporation, with the desire to transform organizational processes and behaviors, and ask, "Why hadn't we ever thought about our business and industry this way before?"
