

## **Sweepstakes Official Rules**

**NO PURCHASE OR CONTRIBUTION IS REQUIRED TO PARTICIPATE IN THE SWEEPSTAKES. OFFER VOID WHERE PROHIBITED. SUBMITTING A SWEEPSTAKES ENTRY BY ANY OF THE MEANS IDENTIFIED BELOW CONSTITUTES ACCEPTANCE OF THESE RULES.**

**Eligibility:** This sweepstakes is open to individuals residing in the continental United States, Alaska, and Hawaii. You must be 21 years of age or older as of the date of entry in order to enter. Offer void where prohibited.

**Duration of Sweepstakes:** The sweepstakes begins at 12 A.M. EST on 06/20/2024 and ends at 5 P.M. EST on 09/09/2024.

**Two Methods of Entry:** No purchase or contribution is required to participate in the sweepstakes. (1) Individuals who make a contribution to Maine Credit Union's Campaign to End Hunger between the dates listed in the Duration of the Sweepstakes above by following the instructions located below are automatically entered in the drawing. (2) Individuals who are not Campaign contributors and who do not wish to contribute to Maine Credit Union's Campaign to End Hunger at this time may enter the drawing by mailing a written request for "ENTRY TO SWEEPSTAKES" with the participant's name, telephone number, physical address, and e-mail address to Maine Credit Unions' Campaign for Ending Hunger, P.O. Box 1236, Portland, ME 04104.

All sweepstakes entries become the property of Maine Credit Unions' Campaign for Ending Hunger. Entries will not be returned. The Campaign for Ending Hunger is not responsible for entries that are lost, late, corrupted, illegible, incomplete, misdirected, or not otherwise correctly received due to technical, administrative, or human error, including, but not limited to, any software, hardware, computer or networking issues, or any other circumstances - technical or otherwise - beyond the Campaign for Ending Hunger's control. At its sole discretion, the Campaign for Ending Hunger reserves the right to modify, suspend, or cancel this sweepstakes if it appears that the integrity, security, or administration of this process may be called into question.

**Selection of Winners:** The random drawing for the grand prize will occur on 09/09/2024 in private at a Maine Credit Union League actual or virtual office space. The grand prize winner will be notified by 9/13/2024 via phone. The prize winner will be notified at least once per business day for five (5) days beginning on the day the entry is drawn and will have seven (7) days to respond to the prize notice. If the prize winner does not respond within seven (7) days from the initial notification, then the Campaign for Ending Hunger will randomly draw a new prize winner from the remaining entries and the first prize winner shall be voided. The new prize winner shall be subject to the same rules. The prize winners who notify the Campaign for Ending Hunger within the required time period and accept the prize will be sent a W-9 form as applicable for the prize value.
